TAA Final Deadline for FY2011 Applications is Tomorrow

For shrimpers that are not participating in the FY2010 Trade Adjustment Assistance for Farmers (TAAF) program, the deadline for applications for the FY2011 TAAF program is **tomorrow, December 23, 2010**. We have been reminded that late applications will not be accepted by the U.S. Department of Agriculture (USDA).

Applications for TAAF (Form FSA-229-1) can be downloaded from the website www.taaforfarmers.org by clicking on "Shrimp (Applied After Sept 24)" and must be submitted to your local Farm Services Agency office
